- Please return this form to Auckland Council with the applicable application fee. Details about fees can be found on [aucklandcouncil.govt.nz](http://aucklandcouncil.govt.nz) or by calling 09 301 0101.
- Our Animal Management team will arrange an appointment to visit your property.
- An Animal Management Officer will then inspect your property and assess it based on the following: size and nature of dogs, size of the confinement area, number of dogs, history of the dogs and owner, nature and dimensions of the property.
- If everything is satisfactory we will send you your licence to keep more than two dogs aged three months or over.
- The licence can be revoked if any conditions of the licence are breached, or any substantiated complaints are made against the dogs kept on the property.
