Summary and staff recommendations

1. Progress renewal of Waikōwhai boardwalk (shown on “Overall Location Plan” as Manukau Coastal Walkway)
2. Progress completion of high priority tracks (shown in red) in Waikōwhai Park (excluding track below access road from Hillsborough Road)
3. Progress renewal of link track in Kingswood Reserve
4. Continue to progress track renewals over future years based on priorities and available budget
5. Renewals work will generally be completed over summer periods.





Next steps

1. Proceed with staff recommendations
2. Updates of progress will be provided through the Parks and Community Facilities monthly updates.
