Plan Change	Plan Change 94 - Wairaka Precinct In Carrington Road, Mt Albert
Application description	 Plan Change 94, in summary, proposes the following: a) Parts of the current Special Purpose - Tertiary Education Zone no longer to be occupied by Unitec are proposed to be rezoned to the adjoining Business - Mixed Use Zone. b) A further strip of land is to be rezoned from Special Purpose -Tertiary Education to Residential - Mixed Housing Urban, adjoining existing land with that zoning in the southern part of the precinct. c) A revised precinct plan and revised precinct provisions are also proposed, with the principal change sought being to allow for greater height for residential buildings. d) The precinct is proposed to be renamed Te Auaunga Precinct.

The above proposed private plan change will be heard by Hearing Commissioners **Greg Hill** (Chairperson), TBA, Councillor Chris Darby and TBA at a hearing to be held as follows:

Submitter non-expert evidence and legal submissions have been requested to be provided by **12 noon on Wednesday 13 November 2024**

The submitter is required to provide:

- 1 hard copy of the evidence
- 1 soft copy briefs of evidence to be provided via email or on a data stick, each file should be less than 10Mb.

Any submitter who is providing a personal statement to read at the hearing, are encouraged to provide these electronically to the Hearings Advisor by midday, two working days prior to the hearing as well as bringing 1 copy to the hearing. This will allow for contactless exchange of evidence and enable parties, whether in attendance or participating virtually to view the material prior to the hearing. If you have not provided the statement in advance of the hearing, please bring 7 hard copies with you.

- (d) A short-written summary for briefs of evidence in excess of 10 pages is helpful. It is likely the commissioners will request that this at least is read at the hearing.
- (e) Email will be the address for service for the submitters unless advised otherwise.
- (f) If the hearing is held virtually, or you plan to attend virtually, please ensure your evidence is provided to the Hearings Advisor electronically before the hearing commences. The panel members will have already read your original submission and they will have that in front of them at the hearing.

If you wish to attend the hearing, please fill in the attached appearance form and return it to me by Tuesday 29 October 2024.
