**Particular Issues**


- 4 BA Anderson Family Trust is interested in the following particular issues:
- (a) Failed to consider or investigate alternative sites, routes, or land use designations.

**Relief sought**

- 5 BA Anderson Family Trust supports the relief sought by Future-Kumeu because:
- (a) Designation should be cancelled until master planning for the Kumeu/Huapai township has been undertaken, with all stakeholders consulted.
  - (b) That full flooding is mitigated in the Kumeu/Huapai township.

**Dispute resolution**

- 6 BA Anderson Family Trust agrees to participate in mediation or other alternative dispute resolution of the proceedings.
