Apologies for lack of recent communication on my behalf but we've been very busy in our team as a bit of transformation in terms of personnel and processes which are taking place.

Actually a major part of this, in my role anyway, was to devise a process to enable us to provide timely, quality and informed cultural advice for the clients.

To track the progress of each project we are utilising Monday.com to ensure procedures and deadlines are met. To this end I was wondering if you could send me a timeline on this project from where we, at Ngati Whatua Orakei, were involved up until the (projected) completion of the development. As an aside, how long do you anticipate the Resource Consent for 'The Hill' to take before you have a response. We're wondering how much faster it may be if it has been fast tracked.

I will then enter this into Monday.com and our current and future staff will be able to take over the project with all the background information logged by me, if I move on or not available. This would also enable us to lodge 'EOI's' on design etc when the timeframes for this are being advised, to save us requesting more time due to our shortcomings like at Te Tatua o Riu-ki-uta.

I also remember at a meeting that there may be capacity to look at developing some form of relationship with landscaping. If so this is an area Ngati Whatua Orakei would like to investigate, due to our ecological unit at Pourewa and the rangatahi we employ there from our iwi.

Jane sorry to put all this on you in light of my tardiness to reply to your email below.

However, even though you have submitted your Resource Consent, if it's not too late I would still like to send an email in support of the proposal of works at the Hill whilst referring to our ongoing relationship at Three Kings and how well that has worked for both of us.
