We, Zhide ZHAO (the house owner) and Yibin CHEN (the land owner), appeal a decision on a notice of requirement for a designation for supporting growth north.

We made a submission on the notice of requirement. I received notice of the decision on 23 January 2025.

The decision was made by Waka Kotahi NZ Transport Agency (NZTA). I am not a trade competitor for the purposes of section 308D of the Resource Management Act 1991.

We are not directly affected by an effect of the subject of the appeal that—

Adversely affects the environment, and does not relate to trade competition or the effects of trade competition

The decisions that I am appealing are NoR 1 – Rapid transit corridor (NZTA) and NoR 4 – SH1 improvements (NZTA)

State a summary of the decision or part of the decision: NoRs should be confirmed subject to conditions (See the copy of the relevant decision).

The site or place to which the requirement applies is 17 Wright Road, Redvale, 0794

The reasons for the appeal are as follows:

This land was sold by tender by the NZTA through the agent, DTZ New Zealand, to the landowner who was told that the land was no longer needed. Now the NZTA claims that they will reacquire the land, which is inconsistent with their previous promise. The NZTA's reversal of its earlier decision has breached the trust and the principle of fairness, especially since the current owner purchased the land in good faith based on the NZTA's assurance that it was no longer needed. As permitted by the landowner, Yibin CHEN, a second-hand dwelling was then relocated onto the site by the house owner Mr Zhide Zhao (Graham). Both Zhide ZHAO and Yibin CHEN love this property because it is a rural residential property which provides some unique characters.

I seek the following relief:

It seems that the NZTA can do whatever they want to do no matter whether it is fair or legal no

The house owner, Mr Zhide ZHAO, had his driver's licence (class 1, 2 & P) revoked illegally by the NZTA. It was suspected that the police officer, Mr Steve Pavic of the Orewa Police Station, and GoBus Manager, Mr Jayesh Shenoy (the contractor of the AT), and the NZTA staff, Tarage of acted on behalf of the NZSIS to unlawfully punish Zhide ZHAO. They violate human rights and the New Zealand Bill of Rights Act. Hopefully this property acquisition is not related to the NZSIS and its gang stalking members' bullying, harassments, intimidation, home invasion, ect. over the years.

I am writing to you regarding 17 Wright Road, Radvale, Auckland that is affected by the project.

I oppose the project and I have expressed my objection to the Supporting Growth Team at the very beginning.

As permitted by my brother-in-law (Yibin CHEN), the landowner, I relocated a 2nd hand dwelling to 17 Wright Road and started living there. I like the area. However, I have been seriously bullied, harassed, intimidated, discriminated against, harms and so on by a secret racial group, its mercenaries, also some government agencies, organisations (including NZTA) in the past 5+ years. For example, the house has been secretly invaded so many times, the valuable stuff and some personal items have been taken/stolen, the house has been damaged in many ways, etc. These suspects are under the policy guidance so my complaints to the agencies, departments and organisations in New Zealand have turned out to be no resolution. I then have to complain to the international organisations (Ref: OTP-CR-551/22).

There are a lot of additional detailed information which I can provide later as I just submit my objection at this stage.

However he has been treated very badly in the past 5 year or so. I'll stand up for my brother-in-law until his issue is resolved in NZ.

Respectful New Zealand Independent Police Conduct Authority

First of all, Happy New Year to the IPCA team.

This is my second time complaining to the IPCA. My first complaint was in 2021 (Ref: IPCA 21-7740). The IPCA manager, Mr Griffyn Gully Davies, did not investigate the police officer, Steve Pavic, which was incorrect because it caused a lot serious inhuman harassments and intimidation afterwards.

There are two main aspects that I would like to complain about this time.

1. The police officer, Mr Steve Pavic, who works at the police station in Orewa, Auckland I complained to the IPCA in 2021 regarding the police, Steve Pavic's malicious discrimination and abuse of his authority. The Manager of the IPCA, Mr Griffyn Gully Davies did not investigate the case further which was wrong and has since then led to a series of inhumane violation.

A few years later, I now know that the incident in 2021 that I reported to Steve Pavic at the Orewa police station was harassment and bullying by the NZ Security Intelligence Services (NZSIS) and its gang stalking members in Auckland. My bus was at the intersection of the Hibiscus Coast Highway, and some of the street lights were switched off. The length of the traffic lights in the intersection had been shortened. There were also a couple of vehicles hidden in the surrounding area, acting as a Gang Stalking harassment support team. Since I had to perform my bus duties to pick up the commuting customers, I had no time to get entangled with them. However, I did report this to the Manager of GoBus Silverdale and went to the Orewa police station to report the incident. Unfortunately, the police officer, Steve, abused his authority and, in collusion with Tara of the NZTA, requested me to provide a psychiatrist report. Otherwise, they won't believe my incident report. I would like to know if everyone who reports an incident to the police has to go through a mental health assessment so that the police can verify the accuracy of the report. Can the police provide a document that shows this is a mandatory procedure? If not, then it appears to be discrimination and an insult. Moreover, there has been full monitoring of the bus when it is on duty. I requested to review the record of bus monitoring but was refused by the GoBus management team. My report to the police includes the incident location and time, so the police should be able to obtain the video record from the bus company. However, the police did not make any effort and instead pushed me to do the psychiatrist assessment, which was extremely bullying behavior and a violation of human rights. This is not acceptable. Therefore, my driver's licences (including class 1, 2, and P) have all been revoked. My right to work and my means of livelihood have been taken away illegally. These actions are against human rights and involve breaching the police code of conduct and procedures. I would like the IPCA to reinvestigate the case under the new government leadership and the new police commissioner. I deserve fair treatment and respect for my personality, even though I am a bus driver. I also deserve my rights to live normally, which include my work as a bus driver and my right to drive my own car.

I have reported to NZ Police more than 80 times so far. The attached is today's 105 police online report.

2. Auckland Police Helicopters - Air Support 'Eagle' Unit

Auckland police helicopters have been bullying me for many years, including by harassing my bus operations. More seriously, they started to use infrasound waves (or similar waves) to attack my heart in May 2024. My heart was pounding abnormally and I felt very uncomfortable when I was attacked. The colour of the helicopter that used to attack my heart at midnight is lighter (compared to the black eagle). The police helicopters are being used to attack New Zealand citizens, especially to lynch and torture senior members of ethnic minorities. Using unconventional weapons to attack people is against New Zealand law and also against international covenants. This must be investigated to find out who gave such instructions.

The bullying and infrasound wave attacks from Police helicopters – Air Support 'Eagle' Unit must be stopped immediately!

The police officer, Steve Pavic, at Orewa police station should take responsibility for his misconduct.

I urge the IPCA to take the issue seriously.

NOTICE OF DECISION OF NZ TRANSPORT AGENCY WAKA KOTAHI UNDER SECTION 172 OF THE RESOURCE MANAGEMENT ACT 1991

Thank you for the recommendations received on 8 November 2024 from the Auckland Council Independent Hearing Commissioners in relation to the four New Zealand Transport Agency (NZTA) Notices of Requirement (NoRs) that comprise the North Projects:

- NoR 1 New Rapid Transport Corridor (RTC) between Albany and Milldale
- NoR 2 New Milldale Station and Associated Facilities
- NoR 3 New Pine Valley East Station and Associated Facilities
- NoR 4 SH1 Improvements

The Commissioners' recommendation was that the NoRs should be confirmed subject to conditions.

Pursuant to section 172 of the Resource Management Act 1991, NZTA accepts the Commissioners' recommendation that the NoRs should be confirmed and accepts in part and rejects in part the Commissioners' recommendations on conditions of the NoRs.

Table 1 below sets out:

- The Commissioners' recommended conditions which are rejected or partially accepted, along with the reasons for NZTA's decision; and
- Other modifications that NZTA has made to the conditions for consistency, clarity and ease of implementation.

Only those recommended conditions that NZTA has modified are outlined in the table below (shown in **bold strikethrough** for deletions and **bold underline** for additions).

A schedule of amendments that have been made to the proposed designation boundaries since lodgement is contained in the Closing Legal Submissions. A subsequent Memorandum of Counsel confirmed a

boundary adjustment for NoR 4 - SH1 improvements, whereby part of the proposed designation was removed from the North Shore Vintage and Classic Car Club site at 40 Masons Road, Albany. An updated schedule of modifications to the proposed designation boundaries for NoRs 1-4, including the modification at 40 Masons Road, is attached as **Appendix A**. NZTA confirms all of those modifications as part of this decision. Updated GIS files will be provided to Council by separate email.

Complete clean sets of designation conditions as a result of the NZTA decision are attached to this letter as **Appendices B - H**. The clean set of conditions includes the changes set out in the table below, formatting changes (including rearranging order of conditions), and minor non-substantive formatting and grammatical changes (such as capitalisations) which have not been tracked in the table below.



I made my initial complaint to the Ombudsman (in Chinese) and copied to IGIS (enquiries@igis.govt.nz) on 16 October 2024. However, I am not sure if you received my complaint email. Due to my English language barriers, Sophie, a staff member at the Ombudsman, advised that I could submit the complaint in Chinese.

I am writing to lodge a formal complaint regarding serious unlawful actions that I believe have been carried out by the Security Intelligence Service (SIS) and/or in connection with your organisation, such as the gang stalking members in Auckland. These actions have caused me significant distress, violated my privacy, and compromised my safety, as well as my physical and emotional well-being. Specifically, I have experienced including but not limited the following:

- 1. **Stalking and Harassment:** I have been subjected to persistent stalking and harassment, including but not limited to being followed, monitored, and surveilled without my consent. More seriously, my bus was also harassed while I was on duty, which posed a threat to public safety.
- 2. **Home Invasion:** My place has been unlawfully and secretly entered countless times, resulting in a violation of my privacy and personal security. All jewellery and other valuable items have been stolen during these invasions. Additionally, the property structures, including the roof, have been deliberately damaged, creating potential risks for the residence. etc.
- 3. **Bullying and Intimidation:** I have been targeted with threatening behaviour, both in person and through indirect means, designed to intimidate and coerce me.
- 4. Violation of Human Rights and Work Rights: One of designed means that often used by the SIS has been to label its victims as mentally ill, causing all my statements and reports to be ignored. Then the SIS, in collaboration with certain individual police officers and the NZTA, demanded a psychiatric report before they would consider my police report regarding the harassment I faced during my bus duties. They failed to follow proper procedures, such as reviewing the bus performance video records to investigate the truth of my report. Instead, they revoked my driver's licence (Class 1, 2, and P) because I refused to comply with their insulting instructions and unreasonable procedures. This unjust revocation of my driver's licence is a clear violation of my rights as a human being and has resulted in the loss of my livelihood.

5. Use of Infrasound and Electromagnetic Waves (or Similar Waves): I have reason to believe that I am being subjected to infrasound and electromagnetic waves (or similar waves) attacks, which are causing severe physical and emotional harm. The infrasound wave attacks, originating from helicopters, have targeted my heart, causing abnormal heartbeats. The electromagnetic wave attacks, delivered through hidden devices near my place, have targeted my head and brain. These attacks represent an invisible method of harming individuals and must cease immediately. I would like to know who granted the NZ SIS the authority to execute such life-threatening actions.

In summary, the above actions are not only unethical but also illegal, constituting a severe breach of my rights as an individual. They also violate human rights and international conventions. I demand an immediate cessation of all such activities and a thorough investigation into this matter. Please treat this issue with the urgency and seriousness it deserves.
