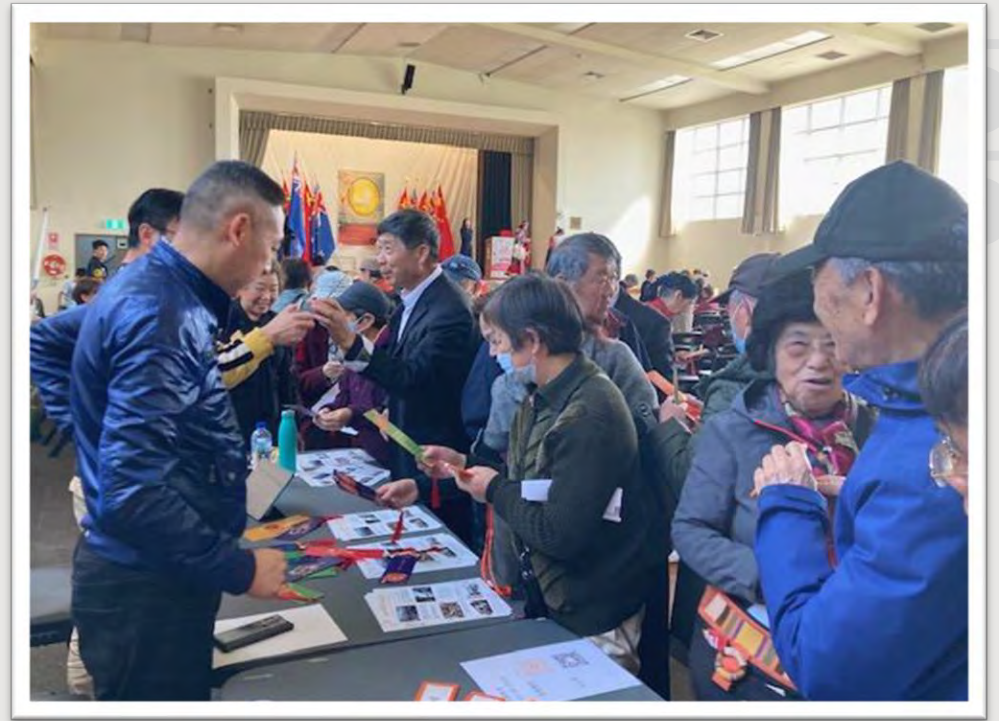

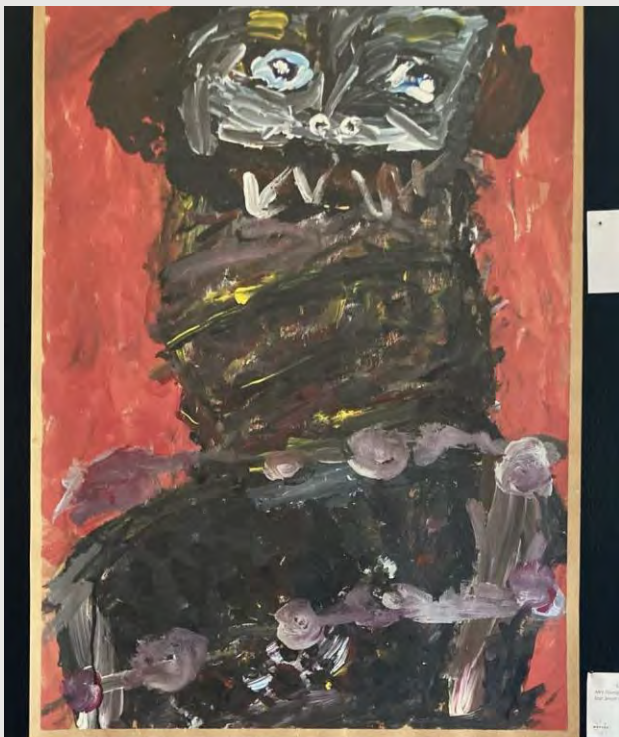

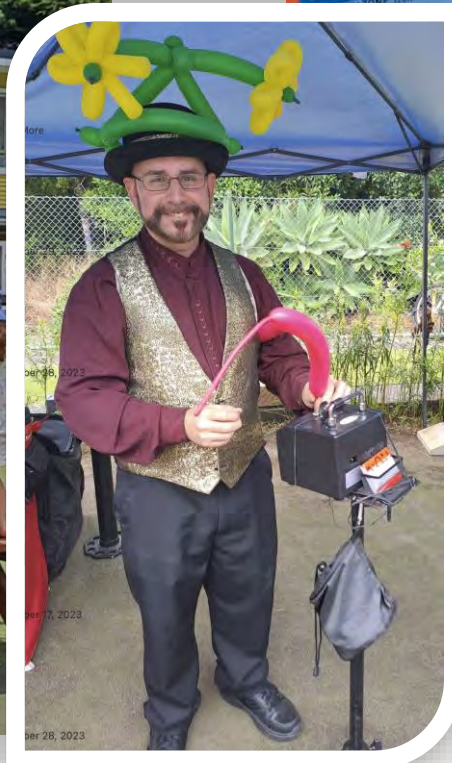

Albert-Eden Local Board key input: investment options

1. Transport:

- support exploring additional revenue opportunities.
- support reducing PT fares but not the reduction of low performing PT services.
- support accelerating PT, walking and cycling.
- support the "PT and Housing Enhancement" programme (\$16B).

2. Water:

- support full "Making Space for Water" programme (Option C - full)

3. Built Environment:

- support urban regeneration programme (Option A - same).

4. Natural Environment:

- accelerate unfunded actions: Infill Development and Ngahere (Option B – more)
- support maintaining current levels of community-led actions (Option A - same).

5. Community Services:

- do not support the proposed options, noting these services are critical for the Local Board.



Albert-Eden Local Board key input: local board proposals

- Support accelerating fairer funding for local boards to address legacy imbalances, with combo of new and reallocated funding
- Support continuing to empower local board with more decisions and budget
 - require increased staff advice to support this
- Support better support for local board decision-making including new task force on asset optimisation
 - need detail on BCR and how responds to 4 wellbeing



Consultation

Budget levers:

- Provide the community a wide range of levers and trade-offs, enabling them to have their say on which options and combos they prefer.
- Ensure information is accessible.
- Provision of tools to inform their thinking (e.g.: budget calculator).



Albert-Eden Local Board advocacy

1. Flood recovery and stormwater management

- Including development of blue-green networks in our area.

2. Funding:

- Retain LDI Opex & Capex and Connected Communities funding.
- Retain capex for town centre upgrades at Sandringham and Greenwoods Corner
- Achieve funding equity for local boards in 3 years
- New funding to deliver a library and community centre hub in Pt Chevalier.
- Funding for Mt Albert pool access to ensure the network is maintained.
- Funding for regional events such as Matariki, Pasifika, Diwali and Auckland Lantern Festival. Add Dominion Road Moon Festival to the regional events calendar.
- Funding the CAB which delivers a critical service
- Support the Western Isthmus Water Quality Improvement programme.

3. Growth:

- Growth funding to respond to the increase in development and support the future community living in our area and for acquiring, upgrading or expanding existing parks, sportsfields and new indoor court facilities.



Albert-Eden Local Board advocacy (to AT)

- Reinststate the Auckland Transport Connected Communities project, which provided more travel options, safer streets, improved town centres, walking, cycling and improved bus services along key roads in our area.
- Advocate for reliable and frequent bus and train services.
- Advocate for upgrades in Mt Albert, Kingsland, Sandringham, Greenwoods Corner and Dominion Road town centres.
- Advocating for more walking and cycling infrastructure allowing people to use alternative travel options easily and safely, and programmes which promote and help people use them.
- Delivery of walking and cycling paths identified in the Albert-Eden Local Paths (Greenways) Plan, especially key connections such as:
 - Motu Manawa - Howlett Reserve to Heron Park (via road reserve and boardwalks)
 - Western Springs to Greenlane Express – cross town cycle route on St Lukes Road, Balmoral Road and Greenlane West.

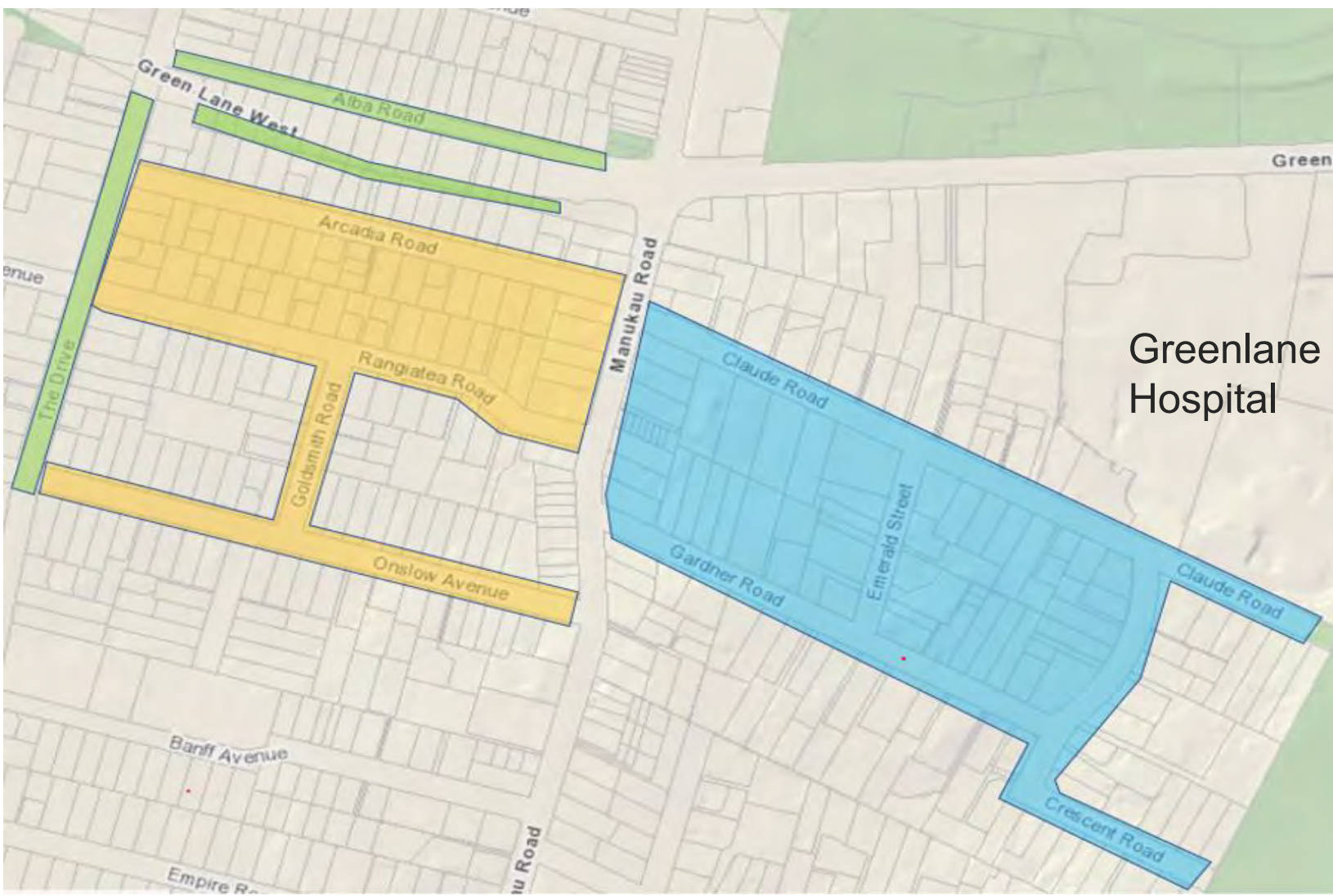
Purpose

- The purpose of this presentation is to inform the Local Board of our intention to engage with the community regarding this residential paid parking zone (RPPZ) and also get any feedback/ comments.

Overview

- The Auckland Transport (AT) Parking Design team conducted a parking occupancy survey in the residential streets surrounding Greenlane Hospital, to better understand the parking behaviour.
- The aim of the study was to analyse the parking situation and provide parking solutions where necessary.

Survey methodology

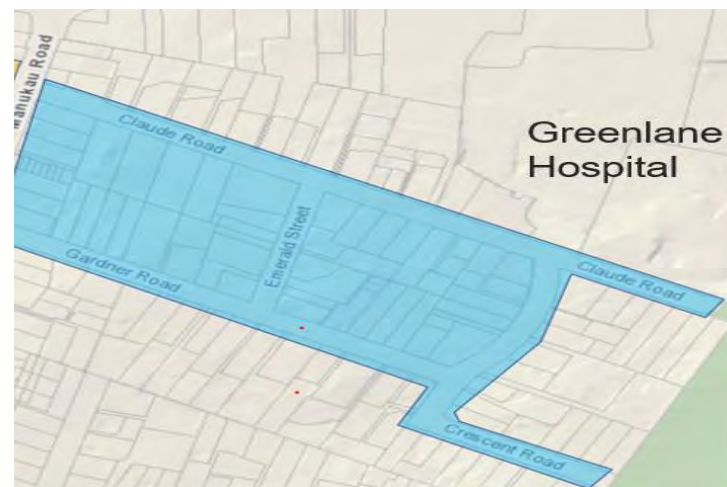
- A number plate survey was done on two hourly basis in the blue area and three hourly basis in the yellow and green areas.
- The survey was conducted on Tuesday September 12th, Thursday September 14th and Saturday September 16th 2023 between 8am and 6pm

Occupancy heatmap of Study Area



Key Findings – Blue area

- Weekday average peak occupancy (APO) of 87% in time restricted area.
- Weekday APO of 93% in unrestricted area.
- Weekend APO was around 40%.
- Approx 92% of the total on-street parking (229/250) is time restricted.
- The average length of stay on weekdays was as follows:
 - P120 – 5 hrs approx.
 - Unrestricted – 6 hrs approx.
 - P60 – 1 hr approx.



Key Findings – Yellow & Green area

- Weekday average peak occupancy (APO) was 48% & 58% respectively.
- Weekend APO was around 42% & 35%.
- Approx. 25% of the total on-street parking is time restricted in yellow area.
- No time restrictions in green area.

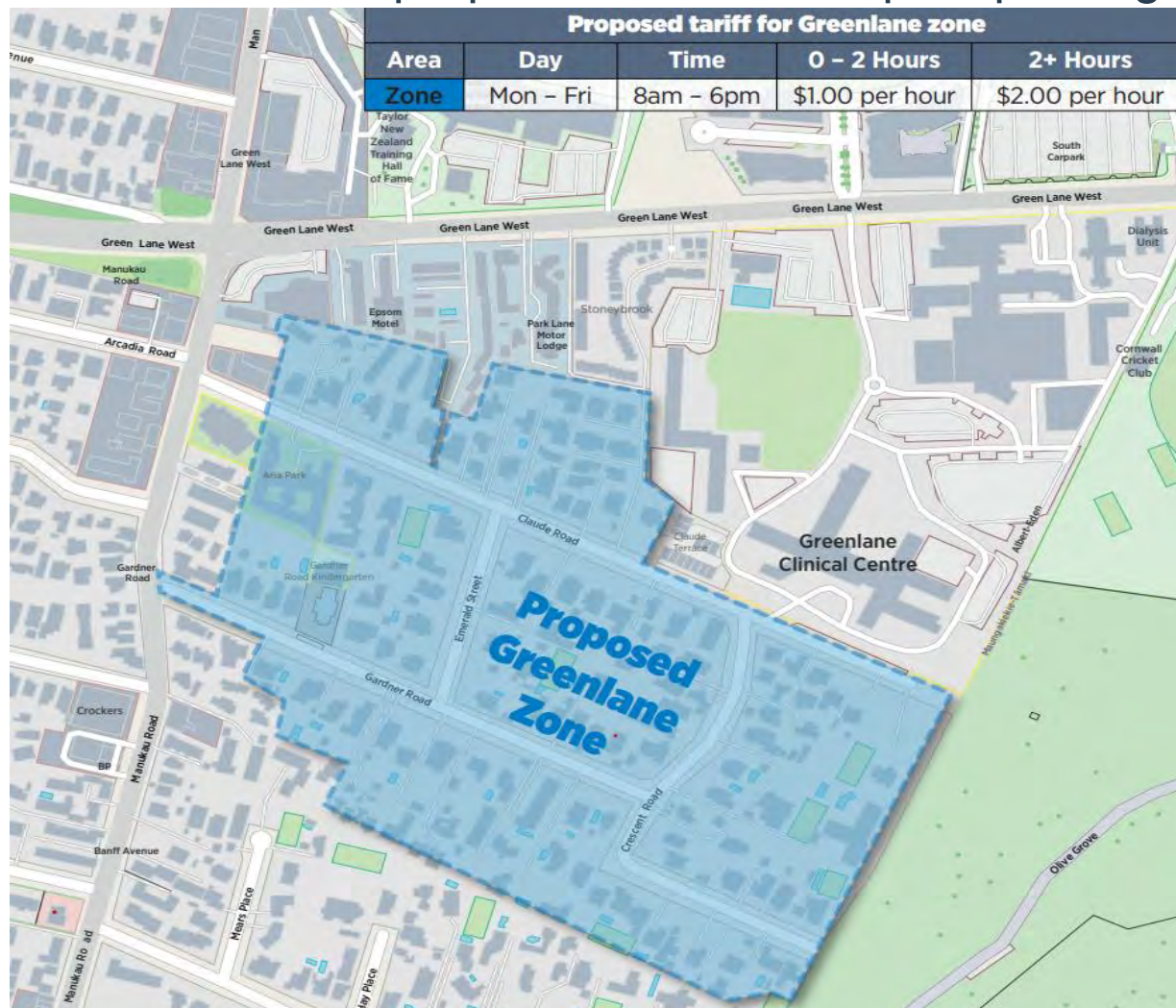

Summary

- The demand for parking was quite high on weekdays in the blue area with APO of 87% & 93% in majority of the area.
- Average length of stay was approx. 5 hrs in P120 & 6 hrs in the unrestricted part of blue area.
- We found that people were overstaying in time restricted areas by almost double the allocated time limits.
- 95% of the parked vehicles were from outside the study area. Only 5% were registered to the addresses within the area on weekdays.
- Approx. 87% of the infringements issued were for overstaying the time limits.

Recommendation

AT recommends to propose a residential paid parking zone.



Benefits

- Address high parking demand & Improve parking availability.
- Offers greater flexibility in length of stay.
- Demand responsive pricing.
- Encourages mode/ ride share.
- Reduces single occupant vehicle/ reduce congestion.
- Improve compliance and enhance safety.
- 10 min. grace period.
