Auckland Transport and Puketāpapa Agreed Local Board Transport Plan





#### Introduction

Kōkiri is Auckland Transport and Puketāpapa Local Board's plan for transport in the local board area.

The role of the document is to establish agreed levels of engagement for programmes of work Auckland Transport will deliver on behalf of the Puketāpapa community.

This plan also includes projects or programmes which are not currently funded, which the local board wants to make sure Auckland Transport is aware of and may be able to deliver in the future.

The objective is to provide a public record of transport projects and programmes in this local board area, and how the local board is engaging with Auckland Transport, including:

- How the board is collaborating with Auckland Transport on projects and programmes, how the board is leading consensus building, and how Auckland Transport is maximising the local board's ability to change or modify the plan.
- How the local board is actively involved in planning and consultation.
- The local board's level of interest in the plan and how Auckland Transport keeps it regularly informed about progress.

Kōkiri is produced annually. This document covers from 1 July 2024 to 30 June 2025.

#### **Background**

The Puketāpapa Local Board borders the Manukau Harbour and includes the suburbs of Three Kings, Mt. Roskill, Hillsborough, Waikōwhai, Lynfield and Wesley.

The area has one of the most culturally diverse residential communities in the Auckland region and a large amount of business land.

#### The significant natural landscapes within the Puketāpapa Local Board area are:

- The Tūpuna Maunga of Te Tātua-a-Riukiuta/Big King and Puketāpapa/Pukewīwī/Mt Roskill. These are cogoverned by the Tūpuna Maunga o Tāmaki Authority.
- Te Auaunga/Oakley Creek which is one of Auckland's longest urban streams, flowing from Hillsborough through Mt Roskill, Owairaka and Waterview to the Waitematā Harbour.
- The Waikōwhai Coast and Manukau Harbour.


In Puketāpapa, Māori number around six per cent of the population, compared with 12 per cent for the whole of Auckland. Most of these residents will be mataawaka (Māori who whakapapa to a different area). Some will be mana whenua (Māori who have a tribal connection to this rohe).

#### **AT Consult projects and programmes**

Auckland Transport has a range of projects and programmes being delivered within the Puketāpapa Local Board area. This map shows the Consult projects and programmes, including their locations. The projects are colour-coded based on the level of engagement the local board has agreed with Auckland Transport.



#### Consult - light blue

Auckland Transport projects or programmes that the local board has identified as requiring a high-level of community representation. Auckland Transport leads the project or programme but works with the local board, providing opportunities for it to input into the plan.

If possible, AT incorporates the local board's feedback into the plan; and if it is not able to, provides clear reasons for that decision.

- 1 Constructing a refuge island at Stamford Park Road (between Melrose Road and Rainford Street) pedestrian improvements.
- 2 Melrose Road and Olsen Avenue pedestrian improvements including kerb build out and refuge island.
- 3 Mt Eden Road and Duke Street intersection improvement.

- 4 Mt Eden Road and Landscape Road intersection improvement.
- 5 Penney Avenue speed calming on 74 Penney Avenue, Mt Roskill.
- 6 St Andrews Road Three Kings School upgrade to pedestrian crossing at 268 St Andrews Road.

#### **AT Inform projects and programmes**

Auckland Transport has a range of projects and programmes being delivered within the Puketāpapa Local Board area. This map shows the Inform projects and programmes, including their locations. The projects are colour-coded based on the level of engagement the local board has agreed with Auckland Transport.



#### Inform - orange

Auckland Transport projects or programmes that the local board wants to be regularly updated about.

Auckland Transport leads the project or programme, informing the local board about progress. AT may ask local board members to provide their knowledge and insights, but there is no expectation that the project must be modified based on that input.

- Building a new raised signalised pedestrian crossing near 127 May Road.
- 2 Upgrading the crossing on Mt Albert Road outside Marcellin College.
- 3 Traffic flow and safety improvements on Stoddard Road between Sandringham Road and Maioro Road.
- 4 Traffic flow and safety improvements on White Swan Road outside Lynfield College.

- 5 Building a bus layover and driver rest on Hillsborough Road.
- 6 Dominion Road and Denbigh Avenue intersection improvements.
- 7 Richardson Road between Glass Road and 653 Richardson Road raised pedestrian crossing, speed cushions, new speed table and zebra crossing markings on the existing speed table.

#### **AT Advocate projects and programmes**

Auckland Transport has a range of projects and programmes being delivered within the Puketāpapa Local Board area. This map shows the Advocate projects and programmes, including their locations. The projects are colour-coded based on the level of engagement the local board has agreed with Auckland Transport.



#### Advocacy - red

Not on map - empty circle

This category includes transport projects or programmes that the local board would like Auckland Transport to deliver but are not currently funded.

This category is an opportunity for the local board to share the expectations of their community. This gives Auckland Transport information to help with future planning; or to modify programmes if funds become available during the year.

- Provide safety improvements at the Denbigh Avenue and Dominion Road roundabout.
- Investment in footpaths and the cycling network, including accelerating footpath renewals in the Puketāpapa Local Board area.

### Accountability and reporting back – Auckland Transport will:

Report on this agreement every three months, and at the end of the term present Puketāpapa Local Board and the community with a full-report on progress towards meeting agreed expectations.

Provide a regular monthly update to the local board by email that will focus on how it is meeting the agreed expectations.

Survey all local board members four times a year to see how satisfied they are with Kōkiri.

In late-2024, after the first iteration of Kōkiri is signed off by local boards, will review the process and work with local boards to identify opportunities for improvement that can be introduced for the next round of plans.

Finally, in late-2025, will work with all local boards to review Kōkiri 2024–25, so as to identify and implement opportunities for improvements in the next iteration.

#### **Executive Summary**

 The goal of the Local Board Relationship Project is to improve how Auckland Transport (AT) engages with local boards. The project's aim is to start building a more community focused and place-based approach to how AT designs, engages about and delivers its work programme.

2. This memo provides AT's response to local board feedback about the Forward Works Engagement Programme (FWEP).

#### **Background**

- 3. Part of the Local Board Relationship Project is producing a plan of agreed engagement on project or programmes AT has planned in their area. This will be the Local Board Transport Plan and the agreement it produces is called Kōkiri (meaning coming together).
- 4. The aim is that a structured process understood by all participants, will provide the basis for better communication and therefore understanding of roles, responsibilities, limitations, and opportunities. The process is based on the Council Controlled Organisations (CCO) Engagement Plan and Auckland Council's successful changes to how its Community Facilities department works with local boards. Essentially, using successful programmes as the starting point for a process of discussion and policy development with local boards.
- 5. During the FWEP briefings and follow up workshops with each local board, AT provided quality advice and support to consider this advice alongside the Local Board Plan.
- 6. In March, this local board provided resolutions stating their community's expectations of AT's proposed work programme. This memo records AT's response to the local board's feedback.
- 7. The process is based on several activities being undertaken as follows:
  - a) Late 2023: AT provides quality advice to all local boards about its work programme and about their ability to influence projects or programmes.
  - b) **February March 2024:** Local boards provide feedback to AT about their community's expectations from AT's work programme.
  - c) April May 2024: AT responds to the local board feedback.
  - d) June July 2024: A Local Board Transport Plan (Kōkiri Agreement) confirms the agreed level of engagement between AT and the local board over work being delivered in the area.





- 8. The overall, aim of this process is to identify AT projects and programmes that the local board is interested in; and to clearly express the level of engagement that members would like to have with AT regarding the project.
- 9. The levels of engagement are derived from the International Association for Public Participation's (IAP2) doctrine; and are as follows:
  - a) Collaboration: AT and the local board are working together to deliver the project or programme. The local board leads the process of building community consensus. The local board's input and advice are used to formulate solutions and develop plans. Local board feedback is incorporated into the plan to the maximum extent possible.
  - b) Consultation: AT leads the project or programme but works with the local board providing opportunities for it to input into the plan. If possible, AT incorporates the local board's feedback into the plan; and if it is not able to provides clear reasons for that decision.
  - c) Informing: AT leads the project or programme informing the local board about progress. Local board members may be asked to provide their local knowledge and insight by AT, however there is no expectation that the project must be modified based on that input.
- Additionally, there may be projects or programmes that a local board wants to deliver but that are not currently identified in AT planning. Local boards may choose to advocate for these projects or programmes.
- 11. Lastly, there may be projects or programmes that the local board believes the community is adamantly opposed to that should be brought to AT's attention. This report provides an opportunity for the local board to express its community's concerns about proposed work.

#### Summary

12. This memo records AT's response to the local board's feedback and will form the Local Board Transport Plan and the agreement it produces called Kōkiri. It shows AT's level of engagement with the local board on the projects within the Forward Works Plan as indicated in the tables below. AT will provide a business meeting report quarterly on progress towards meeting agreed expectations. Local boards can provide formal feedback through that process. The Local Board Transport Plan (Kōkiri Agreement) 2024-25 will be reviewed in late 2025 to identify and implement opportunities for improvements in the next iteration of the plan.





#### **Auckland Transport's Responses**

- Green indicates that the project of programme can enter AT's annual Local Board Transport Plan (Kōkiri Agreement) at the requested level of engagement.
