#### Introduction

This is a further submission in support of submissions on the Council's Proposed Plan Change 78: Intensification ('PC78') to the Auckland Unitary Plan (Operative in Part) ('AUP (OP)') on behalf of Gerrad Hall ('the Submitter'), as trustee of the owners of the property at 3 Fisherton Street, Grey Lynn ('the site').

The Submitter has an interest in PC78 greater than the general public has, given that they own land that is subject to PC78 and specifically the Combined Wastewater Network Control, which is proposed to apply to the site. The submitter is opposed to this control applying to the site.

#### Summary of Submission and Relief Sought

The Submitter **supports the following submission points**, which seek to remove the Infrastructure – Combined Wastewater Network Control from PC78:

- 351.10 (iSolutions);
- 873.48 (Kāinga Ora);
- 1079.69 (The Coalition for More Homes);
- 1304.8 (Janette Jiayi Yan and Mark);
- 1696.3 (Huiqiang Zhang);
- 1962.18 (Aedifice Property Group);

The reasons are that the AUP (OP) already contains provisions that allow infrastructure to be assessed through the resource consent process. Infrastructure capacity changes frequently, and engineering solutions are generally available to address capacity constraints. Infrastructure constraints can also be resolved through funding mechanisms which sit outside of the AUP (OP). In the case of the Submitter's site, resource consent has been granted to further develop the site with additional dwellings. This addresses the constraint that the Control is proposed to regulate, and demonstrates that the AUP (OP) already adequately manages this issue.

 ATR has an interest in PC78 that is greater than the interest the general public has. ATR owns and occupies land, being the Ellerslie Racecourse and adjacent landholdings at 100, 110-120 and 130 Ascot Avenue (together, "Racecourse"), that is directly affected by PC78.

#### Scope of further submission

2. This is a further submission in opposition to a submission on PC78.

#### **Submission opposed**

3. ATR opposes the submission by Kāinga Ora – Homes and Communities, PO Box 74598, Greenlane, Auckland 1051 (submission number 873) ("Kāinga Ora") insofar as it relates to ATR's landholdings, and insofar as it seeks to introduce a height variation control of 22 metres to Mixed Use and Special Purpose – Major Recreation Facility zoned land within ATR's landholdings.

#### Reasons for further submission

- 4. The reasons for this further submission are that the relevant part of the submission above, if accepted:
  - (a) will not promote the sustainable management of resources, and therefore will not achieve the purpose and principles of the Resource Management Act 1991 ("RMA");
  - (b) is contrary to Part 2 and other provisions of the RMA;
  - (c) will not meet the reasonably foreseeable needs of future generations;
  - (d) will not enable social, economic and cultural wellbeing;
  - (e) is contrary to the purposes and provisions of the RMA and other relevant planning documents including the National Policy Statement on Urban Development 2020 ("NPS-UD") and the AUP;

- is inappropriate and inconsistent with the purpose and principles of the RMA; and
- (g) does not represent the most appropriate way to achieve the objectives of the RMA, the objectives of the Auckland Unitary Plan and/or the development objectives of the Medium Density Residential Standards.

#### Specific reasons for further submission

- 5. ATR appreciates the general intent of Kāinga Ora's submission to provide increased heights, by way of a height variation control, to land within ATR's landholdings. However, the proposed control, as illustrated in **Appendix A** below, is inappropriate.
- 6. Without limiting the generality of paragraph 4 above:
  - (a) It is not appropriate to apply a height variation to Special Purpose Major Recreation Facility land at Ellerslie Racecourse. The Ellerslie Racecourse Precinct provisions specifically provide for activities relating to the operation of the racecourse and include rules and standards relating to building height. Introducing a new height variation control would directly conflict with these Precinct provisions.
  - (b) It is not appropriate to apply the height variation control as sought by Kāinga Ora to Business Mixed Use zoned land owned by ATR:
    - (i) A 50-metre building height variation control should be applied to Business – Mixed Use zoned owned by ATR, as sought in ATR's submission. This land is within, or immediately adjacent to, a walkable catchment of the Greenlane Train Station. This more enabling height variation control sought by ATR will better assist to enable intensification required under the NPS-UD.
    - (ii) While the Ellerslie 2 Precinct should be deleted in its entirety, or with amendments, in order to give effect to the NPS-UD, the Ellerslie 2 Precinct – Sub-precinct B currently provides a total building height of 27m (including roof form). Kāinga Ora's proposal will inappropriately reduce the permitted building height limit within this Sub-precinct from what is currently provided.

#### **Decision sought**

- 7. The submission identified above should be disallowed, insofar as it relates to ATR's landholdings, and insofar as it seeks to limit the building heights in the Mixed Use and Major Recreation Facility zoned land owned by ATR to 22 metres.
- 8. ATR wishes to be heard in support of this further submission.

9. If others make a similar submission, consideration would be given to presenting a joint case with them at any hearing.


